Exhibitor Legal Agreement

1. Exhibitor Responsibilities

- (b) any alleged or actual infringement, misappropriation, or violation of any copyright, trademark, patent, license, or other right by Exhibitor; or
- (c) any negligent or intentional act or omission of Exhibitor, its employees, agents, or contractors.

Exhibitor acknowledges and agrees that Show Management is not responsible for policing or monitoring intellectual property or licensing rights at the event and assumes no liability for Exhibitor's conduct, merchandise, or representations.

This indemnification obligation shall survive the conclusion of the Show.

3. Governing Law and Venue

This Agreement shall be governed by and construed in accordance with the laws of the State of Florida, without regard to its conflict of law principles. Any dispute arising under or relating to this Agreement shall be brought exclusively in a court of competent jurisdiction located in Orange County, Florida, and Exhibitor hereby consents to such venue and jurisdiction.

4. Entire Agreement

This Agreement constitutes the entire understanding between Exhibitor and Show Management regarding participation in the Show and supersedes any prior agreements or communications, written or oral, relating to the subject matter hereof. No modification shall be valid unless made in writing and signed by both parties.

Acceptance and Agreement

By submitting this registration electronically, the Exhibitor acknowledges that they have read, understand, and agree to abide by all terms and conditions set forth in this Agreement, including but not limited to the Indemnification and Legal Responsibility Clause. Exhibitor further acknowledges that they have authority to enter into this Agreement on behalf of their business or organization.
